

Across

- 1 Termination or cessation of a period of tenure or legal liability. (6)
- 4 A contract under which the owner of a ship pledges the ship as collateral for a loan to finance a journey. (8)
- 6 Loss or damage caused to the ship or cargo by the wilful act of the master or seamen. (8)
- 8 Permission given to a ship to use a port without quarantine after it has been certified free of disease by competent health authorities. (4,8)
- 13 A party who contracts to carry goods or passengers by water. (7)
- 14 A bill of lading providing for the delivery of the goods to a named person, without also specifying "to order or assigns". (8)
- 15 The party who contracts with a carrier for the carriage of goods by water. (7)
- 16 A bill of lading

- 2 providing for delivery of the goods to the order of a specified person, by words such as "consigned to XYZ Co. Ltd. or to order or assigns". (5)
- 17 A through bill of lading which involves at least two different modes of transport - road, rail, air and sea. (10)
- 20 A charge required as compensation for the delay of a ship or freight car or other cargo beyond its scheduled time of departure. (9)
- 21 Procedure by which the court sets at liberty one who has been arrested or imprisoned, upon receipt of security to ensure the released prisoner's later appearance in court for further proceedings. (4)

- 1 Cost, Insurance and Freight. Internationally recognized sale term critical to negotiations in defining how functions, risks and costs are
- 5 divided when goods travel. (3)
- 2 The punishment given to a person who has been convicted (i.e. found to be guilty) of a crime. (8)
- 3 A rule of evidence whereby a person is barred from denying the truth of a fact that has already been settled. (8)
- 5 A ___ bill of lading provides for the carriage of goods by water, from their point of origin to their final destination, either by successive ocean carriers or by more than one mode of transportation. (7)
- 7 Of or relating to or characteristic of Asia or the peoples of Asia or their languages or culture. (7)
- 8 It means that the seller fulfils his obligation to deliver when the goods have passed over the ship's rail at the named port of shipment. (4,2,5)
- 9 Seizure of a ship (and sometimes cargo and/or freight) by an admiralty

court to provide pre-judgment security for the plaintiff's maritime claim. (6)

- 10 A vessel habitually employed on a regular schedule and loading and discharging at specified ports. (5)
- 11 A ___ bill of lading is issued when goods have been loaded aboard the ship. (7)
- 12 Penalised by way of a charge for some breach. (5)
- 18 A record book carried aboard a ship in which all significant events relating to the journey are recorded by the ship's officers authorized to make such entries. (3)
- 19 Acronym for less than a container load. (3)
